RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

In consideration of being permitted to participate in any way in the UFT Middle School Division 5K Family Run on May 5, 2018, I hereby release, waive, forever discharge, and covenant not to sue the United Federation of Teachers, Local 2, AFT, AFL-CIO (the "UFT"), and its respective affiliates, parents, subsidiaries, officers, directors, representatives, employees, volunteers, trip supervisors and agents (the "Released Parties") from and against any claims, suits, liabilities, causes of action or proceedings of any kind whatsoever arising from, related to or otherwise connected with the UFT Middle School Division 5K Family Run. It is my express intent that this release shall bind me and my personal representatives, assigns, heirs, and next of kin. This release agreement shall be construed to be as comprehensive as is allowed by law, and severable, the invalidity of any portion of which shall not affect any other portion. This Agreement shall not establish a legal or other relationship between or among the persons released by the Agreement.

I hereby elect to voluntarily participate in the UFT Middle School Division 5K Family Run knowing that it may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my participation in the UFT Middle School Division 5K Family Run whether caused by the negligence of the Released Parties or otherwise.

I understand that I am responsible for my own welfare and safety and am required to: (1) abide by all instructions given by event staff and security personnel and (2) comply with all laws and ordinances, including but not limited to those pertaining to prohibiting the possession or use of drugs or alcohol.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
